- The Family Division Judges will be designated for judicial availability to provide immediate review and to rule on verbal requests made by a law enforcement officer, for an immediate emergency ex parte extreme risk protection order (ERPO) pursuant to MCR 3.718(B).
- A duty judge schedule for the week, Monday-Sunday, will be developed and made available to local law enforcement and the 911 emergency dispatch center.
- There will be a designated ERPO after hours phone number provided to law enforcement to contact the duty judge to make an emergency verbal request.
- Attached hereto and incorporated herein as part of the implementation of the local plan is a file with the duty judge schedule for February-July 2024. The schedule will be distributed to law enforcement and the 911 emergency dispatch center and update if changes require.
