

WOMEN'S HISTORY MONTH HONORING SARAH EMMA EDMONDS AND EVA BELLES

In recognition of March as Women's History month, the Hearsay committee is highlighting two courageous women from Flint who are memorialized in the Courthouse Square -Sarah Emma Edmonds and Eva Belles.




Sarah Emma Edmonds

Canadian-born Sarah Emma Edmonds, escaping what she feared would be a life of "enslavement" as a woman, took on the identity of a man, Franklin Thompson.

On May 25, 1861, Edmonds (as Thompson) enlisted in the Union Army and fought in the American Civil War. Edmonds enrolled in Company F, Second Michigan Infantry, disguised as Franklin Thompson, and saw action at the first Battle of Bull Run and, as part of the Army of the Potomac, at Second Bull Run and Fredericksburg.

Thompson's true identify remained a secret until Edmonds applied for a combat duty pension from the U.S. Army twenty years later. On July 3, 1886, Congress granted Sarah Emma Edmonds Seelye an honorable discharge from combat duty and a pension.

A historical marker of Edmonds / Thompson is located on the grounds of the Courthouse Square, at the intersection of West Court Street and Saginaw Street.



In April 1888, Eva Belles tried to vote in a Flint school board election. However, because she was a woman, the election inspectors refused to receive her


Belles sued in Genesee County Circuit Court and won. The election inspectors appealed, and the Michigan Supreme Court upheld the lower court.

As a result, women like Eva Belles won the right to vote in certain school elections.

Belles' battle paved the way for women's suffrage in Michigan, which would not be achieved until 1918 when the Michigan Constitution was amended to provide full voting rights for women.

THE CHIEF SPEAKS

For this edition of The Chief Speaks, I'd like to get a little philosophical and pose the following question: What is the

In a way, it's easy to answer this: it's what we all do every morning after we brush our teeth and drive to the courthouse. But on the other hand, it can be surprisingly hard to pin down.

Why? Well, for one thing, the law keeps changing. Take any area of the law and you can see it. And you don't have to be a lawyer. All you have to do is read the news and you can see enormous changes in the law with regard to guns, abortion, marijuana and on and on. So the law isn't so much a thing as it is a process. But if there is a big idea, it's that law exists to resolve conflicts. If you and your neighbor are fighting over where the fence goes, you can either have a shootout at the OK Corral or you can file a lawsuit.

But how does the judge decide where the fence goes? A system of government was set up by the US. Constitution to determine how law would be made.

However, the Constitution wants to have its cake and eat it too. It features two contradictory things: effective power, but also limited power. How do you have both? This is how it the Constitution solved it: the effective power would be



vested in a president and a congress, while the limitation of that power would be tasked to the judiciary. Judges.

It was none other than Alexander Hamilton who wrote about judges in the Federalist Papers. (Yes, that Alexander Hamilton, the star of the Broadway show.) He certainly didn't throw away his shot when he described the judiciary as the weakest of the three branches of government. He noted that the president held the sword and the congress held the purse. But what did judges hold? Absolutely nothing! Nothing! (The gavel doesn't count because we can't throw it at the people.)

So the only thing judges have is their good judgment. Think of it—our entire system of gov- just that his daughter Linda ernment depends on judges making good decisions. That's a lot of pressure for us judges.

And that's why we write opinions about how we come to our decisions. Like in eighth grade It would end with the landalgebra, we must show our work. This is for the benefit of the parties—it's a lot easier for lates our Constitution. And the losing side to accept the decision when they understand why they lost. But we also must show our work so that our decisions can be appealed.

My brother is an emergency room doctor. If he makes a mistake, there's no appeal. If I make a mistake, appellate judges can correct it. And I'm grateful that they do. But sometimes appeals courts don't roles in producing the good reverse us because we made a mistake. Sometimes they do it because they want to change the law.

So a case can serve two purposes—one to resolve a conflict between litigants and the another to change the law for all cases. We've all heard

about Brown v Board of Education. This was a case that started at the trial level when Oliver Brown thought it unshould have to ride a bus to a far away segregated school when she could just walk a few blocks to the closest school.

As for the question I posed at the beginning, what is the law? The answer is provided every day by all of usjudges, lawyers, staff, clerks, etc-who play important decisions that aggregate to form the law.

As such, it's important to remember that Linda Brown's case started as a lawsuit in front of a trial judge in a courthouse just like ours. cidin

Specialty Court Services Office Created - Director Hired

The various specialty or "problem-solving" courts in the probate and circuit courts - mental health court, veterans treatment court, family dependency treatment court, and adult felony recovery court - now have a central administrative office and a newly-hired director.

CHILD SUPPORT NAVIGATOR PILO

Around two-thirds of families with Friend of the Court cases start their case with the Michigan Office of Child Support and the Family Support Division of the Prosecuting Attorney's Office.

In the State of Michigan, this partnership of the Office of Child Support, Prosecuting Attorneys, and Friend of the Court make up the child support program.

Over the last several years, there have been efforts to get feedback from families about how they would like to see the child support program improve. One of the suggestions from families was to have "Child Support Navigators" who can assist families as they navigate the challenging child support system. To meet that end, the Office of Child Sup-

port partnered with the W.K. Kellogg Foundation to fund and develop a pilot program in 4 Michigan counties: Calhoun, Kent, Wayne, and Genesee. The Genesee County Friend of the Court was selected in part due to the existing community partner- accessible for those families. ships with non-profit agencies who serve families.

Each pilot community receiving the grant funding will be testing out a different model of the navigator program.

In Calhoun, the efforts will be focused in the Michigan Works office. In Wayne, there will be navigators embedded in multiple different locations around the county. Genesee County will build on the existing relationship with InvolvedDad and a new sub-organization, Family Forward, will offer navigator services to families in Genesee County.

The Child Support Navigators will get training from the Friend of the Court and will be able to assist families who are navigating the family court system, without providing legal advice, in locations that will be easy and

It is expected that navigators will be out at community locations and will be connecting families to valuable resources.

The Genesee County navigator pilot will begin this summer and will last for one year. At the end of the one-year pilot, there will be a one-year evaluation of the program. The evaluation will be a rigorous evaluation to determine what lessons can be learned from rolling out a navigator pro-

As the Court continues our efforts to develop a robust Legal

Resource Center, we are hopeful that this pilot program and funding will open up additional opportunities to serve the families who are navigating the family court.

It is an honor and a privilege to be selected among the 83 counties in Michigan as a site for this pilot program. We look forward to continuing to partner with the Office of Child Support, the Genesee County Prosecutor's Office, Family Forward, and the families in our community to make this program a success.

We are grateful for the opportunity to infuse our community with additional resources and continue to build the network of programming for those we serve in the Family Division of the 7th Circuit Court. -tm

HEARSAY RUI

The Hearsay Rules appeared in the March 5th 2024 edition.

The law has numerous rules to ensure that there is fairness. Among the most important of these are the hearsay rules which generally prevent the admission into evidence of certain statements.

The following is a brief summary.

(1) the "declarant" does not make while testifying at the a party offers in evidence to prove "the truth of the matter asserted" in the statement.

makes the out-of-court statement.

A statement is a person's oral or written assertion, or nonverbal conduct if the person intended it as an assertion. The truth of the matter asserted means the statement itself is being used as evidence to prove the substance of the statement.

So if a witness testifies a declarant said "John told me that Larry is his friend" to prove John and Larry are friends, it's inadmissible hearsay.

Hearsay is a "statement" that: The reasons for the hearsay rules or condition made while or imcenter around out-of-court state- mediately after the declarant ments not being admissible be-

nation or a guarantee of reliability.

There are 24 hearsay exceptions The declarant is the person who which have sufficient reliability along with other out-of-court statements which aren't hearsay and therefore admissible.

> A few of the most common exceptions are:

"Excited Utterance" when the statement is related to a startling event while the declarant is under the stress or excitement of the event or condition such as a declarant saying, "The car is on fire."

"Present Sense Impression" when there is a statement describing or explaining an event perceived it, an example being a current trial or hearing; (2) and cause there can't be cross examideclarant telling the police about

an event within 15 minutes after it occurred.

A statement of the declarant's then existing state of mind or emotional, sensory, or physical condition such as intent, plan, motive, design, mental feeling, pain, or bodily health such as a declarant saying "she's afraid."

An example of an out-of-court statement not being hearsay is when it is made by one party and offered into evidence by their opponent.

There are other exceptions and non-hearsay examples too numerous to mention here.

Suffice it to say, judges and lawyers must know the hearsay rules backwards and forwards as "hearsay" is a frequent objec-

The first female Genesee County Judge of Probate (this is the correct way to refer to a Probate Judge, as told by the late Judge of Probate Allen J. Nelson) is Judge Jennie E. Barkey aka notorious JEB (2006)

The first female 68th District Court Judge was Judge Judith A. Fullerton (1980) The first female African American 68th District Court Judge was Judge Lee Vera Lloyd (1983-1985)

The first female 67th District Court Judge was Judge Arthalu Lancaster (1989)

The first female Justice of the Michigan Supreme Court was Justice Mary S. Coleman (1972) and the first female Chief Justice (1979).

The first female president of the Genesee Conty Bar Association was Arthalu Lancaster (1987-88)

The first female African American Genesee County Circuit


Court Judge is Judge Celeste D. Bell (2018)

GOVERNOR CRAPO AND WILLSON PARK



When Governor Henry H. Crapo, Michigan's 15th Gov ernor, brought his family to Genesee County from New Bedford, Massachusetts in 1858, he built a spacious home on what is now called Willson Park in downtown Flint.

It was a large home with rambling gardens. The home and property were later purchased by Dr. James C. and Rhoda Crapo Willson.

Rhoda was one of Governor but returned east without Crapo's 9 daughters. The couple moved into the home in 1877, after it was occupied by another Crapo daughter and her family.

The home was then left to the only son of James and Rhoda Willson, George Crapo Willson.

Willson offered the park to the City of Flint with the stipulation that it must be used for a public park. It was purchased for \$25,000 in 1913. The home was razed.


Crapo had intended to build elsewhere. Soon after his arrival in 1855 to build lumber mills, he purchased 40 acres which now encompasses a large part of the Flint Cultural Center. In his early diaries, he referred to the area as "hazelwood." Crapo established the mills,

building a home.

When he returned another home had been built on park property and it was available to purchase. He purchased it and began to expand the home and create elaborate landscaping. He was an accomplished student of horticulture.

Crapo was accomplished in business, farming, banking, railroading and politics. He was mayor in 1860, state senator in 1862 and Michigan Governor from 1864-1888. He was Michigan's Civil War Governor.

He maintained the Crapo Farm in Swartz Creek, 1000 acres upon which he raised purebred Hereford stock that was the oldest in the United States. The home he built there and the farm were maintained by Crapo family until 1955. -

As part of the Judicial Outreach encouraged by the Michigan Supreme Court, the 7th Circuit Court has invited seniors from the Flint Southwestern Classical Academy to a tour of the Courthouse on March 5, 2024 where the program will include the introduction of the various careers that are essential to the successful daily operation of the Courthouse. Presentations will be from the Court, Judicial Staff, the Prosecutor's Office, the Public Defender's Office, Building and Grounds, Administration, IT Department, Public Safety, Library/ Resource Paralegal, and the Jury Board. In utilizing this opportunity, it is our hope that the students will be able to explore not only the wide array of positions that are necessary for a court to operate, but to also provide the students with a hands-on demonstration of the many future career opportunities they are presented with. In doing so, the students will receive real-life examples of how the variety of skills and specializations at all different levels come together to form a functioning courthouse.

We have arranged to hand out copies of both the Michigan and United States Constitutions. This will provide another level of immersion, demonstrating how court functions couple with governmental functions, and will provide a big- picture overview of the career field in its entirety. The students will also sit through an actual jury orientation before enjoying lunch on-site. During the jury orientation, we will work to impress upon these students how criti-

cal participation as a juror is to the fair functionality of our legal system. Our hope is to not only introduce the students to the Courthouse with a positive comprehensive overview , but also to highlight the many career opportunities that exist for graduating



students to consider and gain respect for. The mechanics of a courthouse require countless skill-sets and job positions, and it is our hope to demonstrate to the students, in a cohesive manner, that

each and every position is essential in order for the day-to-day operations to run as smoothly as they do. A Michigan Legal Milestone marker memorializing Eva Belles' vote is located in the entryway of the Genesee County Courthouse, Saginaw Street entrance.

There are other historical markers on the Courthouse Square. The Historical Genesee County Courthouse and the former Genesee County Jail are recognized for their architectural significance in a marker on the grounds closest to the Sagianw Street/ Fifth Street intersection.

Another historical marker, entitled Resisting Slavery, is located on the grounds, closest

to Court Street. It is our most recent addition to the Courthouse Square, which has been the location of the Court since the land was deeded by Wait Beach.

There are other monuments on the Courthouse Square in tribute to military events, along



with the cannons which guard- nor of the State of Michigan ed the White House, in Washington, D. C. during the Civil War.

Upon their decommission, they were sent to Michigan as a tribute to the number of union soldiers that came from the state. Governor Crapo, Gover-


during the Civil War, was from Flint. The cannons came to rest and remain here in his honor.

The cannons are maintained by the Sons of Union Veterans of the Civil War. The late Attorney Donald Shaw was very active in the organization and served as its national president. -so
